

## **Code of Conduct**

Midtown Global Market, including its buildings, roadways and parking areas, is private property.

We have set forth the following Code of Conduct to protect the property's business interests and provide the best experience possible for our business owners, their staff and Market patrons.

The Midtown Global Market does not discriminate against any person or group on the basis of race, gender, religion, culture, age, physical disability, sexual orientation, gender identity, status as a military veteran or genetic information.

In order to assist in our efforts to provide a safe, secure and pleasant environment, we ask you to refrain from the following:

## **Prohibited Conduct:**

- Use of racial, religious, gender, or ethnic slurs, or other obscene language or gestures.
- Inappropriate attire includes clothing that deliberately obscures the face, such as hooded tops or masks, unless worn for religious belief and/or medical-grade masks.
- Behavior that is disorderly, disruptive or that endangers others.
- Defacing, damaging, destroying, or shoplifting any property.
- · Littering.
- Obstructing or interfering with free flow of customer traffic.
- Fighting, harassment, shouting, offending others, sexually explicit language, or provoking confrontations.
- Use of property in improper or unsafe manner.
- · Blocking of store entrances, walkways, exits.
- Wearing indecent, inappropriate or gang-related attire.
  All patrons must be fully clothed.

- Smoking (including vaping) inside the property.
  Smoking is only permitted in designated outdoor areas.
- Possession of any item that could be used as a weapon, including but not limited to firearms, explosives, fireworks or sticks (except umbrellas, canes or other medical-type devices), knives, or any other object(s) that may be used in any way to inflict bodily injury on another person, even if legally owned. Weapons of any type are not permitted.
- Consuming alcoholic beverages in NON-designated areas.
- Picketing, leafleting, soliciting or petitioning, unless authorized by management.
- Photographing, videotaping, or filming, unless authorized by management.
- Sitting on areas not specifically designed for seating.
- Leaving unattended bags which are subject to search and possible seizure and impounded into lost and found.
- Bringing animals in the Market with the exception of service animals.

Any person who fails to comply with management or security may be asked to leave the property. Thank you for your anticipated cooperation and for joining us at the Midtown Global Market.

Your entry to Midtown Global Market constitutes your consent to abide by the above rules governing conduct and your acknowledgment that you have no expectation of privacy while you are in the common areas of the Market. Such that you may be photographed, and your communications may be overheard or recorded. A violation of the Code of Conduct may result in expulsion from the property and/or other legal actions as management deems appropriate.
